SHELTER SERVICES - IN 2017, THE CONNECTICUT HUMANE SOCIETY OPERATING THREE ANIMAL CARE AND ADOPTION CENTERS FOUND HOMES FOR 3,572 ANIMALS. COMPANION ANIMALS ARE SURRENDERED FOR ADOPTION BY OWNERS, TAKEN IN FROM LAW ENFORCEMENT AND RESCUED FROM PARTNER ANIMAL SHELTERING ORGANIZATIONS. IN OUR CARE, THESE ANIMALS RECEIVED 7,254 VACCINES, 2,015 SPAY OR NEUTER SURGERIES AND WERE THOROUGHLY CHECKED BY OUR HIGHLY SKILLED STAFF VETERINARIANS. FURTHER, EACH PET WAS EVALUATED USING A NATIONALLY KNOWN BEHAVIOR ASSESSMENT TOOL.
