COMPANION ANIMALS ARE SURRENDERED FOR ADOPTION BY OWNERS, TAKEN IN FROM LAW ENFORCEMENT AND RESCUED FROM PARTNER ANIMAL SHELTERING ORGANIZATIONS. IN OUR CARE, THESE ANIMALS RECEIVED 6,618 VACCINES, 1,876 SPAY OR NEUTER SURGERIES AND WERE THOROUGHLY CHECKED BY OUR HIGHLY SKILLED STAFF VETERINARIANS. ON AVERAGE, EACH ANIMAL RECEIVED 24 DAYS OF CARE AND CONVALESCENCE PRIOR TO TAKING JUST 48 HOURS FOR REHOMING. VETERINARY CARE WITH EXTENSIVE SUPPORTIVE CARE INCLUDING FOSTER CARE PROGRAMS HELP TO PREVENT ANIMAL SUFFERING, KEEP PETS IN THEIR HOMES WHEN POSSIBLE, REDUCE EUTHANASIA, AND OTHER FORMS OF ANIMAL CRUELTY AND NEGLECT. ANIMALS RECEIVE FOOD, SHELTER, MEDICAL CARE,
