COMPANION ANIMALS ARE SURRENDERED FOR ADOPTION BY OWNERS, TAKEN IN FROM LAW ENFORCEMENT AND RESCUED FROM PARTNER ANIMAL SHELTERING ORGANIZATIONS. IN OUR CARE, THESE ANIMALS RECEIVED 6,664 VACCINES, 1,911 SPAY OR NEUTER SURGERIES AND WERE THOROUGHLY EXAMINED, BY OUR HIGHLY SKILLED STAFF VETERINARIANS. ON AVERAGE, EACH ANIMAL RECEIVED 26 DAYS OF CARE AND CONVALESCENCE PRIOR TO TAKING 5 DAYS FOR REHOMING.
