COMPANION ANIMALS ARE SURRENDERED FOR ADOPTION BY OWNERS, TAKEN IN FROM LAW ENFORCEMENT AND RESCUED FROM PARTNER ANIMAL SHELTERING ORGANIZATIONS. IN OUR CARE, THESE ANIMALS RECEIVED 3,462 VACCINES, 951 SPAY OR NEUTER SURGERIES AND WERE THOROUGHLY EXAMINED, BY OUR HIGHLY SKILLED STAFF VETERINARIANS.
